### WHAT DOES MIZRAHI TEFAHOT BANK LTD., LOS ANGELES DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and employment information
- Account Balance and transaction history
- Credit information and income

When you are *no longer* our customer, we continue to share your information as described in this notice.

#### How?

All financial companies need to share **customers'** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **customers'** personal information; the reasons Mizrahi Tefahot Bank Ltd. chooses to share; and whether you can limit this sharing.

We collect your personal information, for example, when you

- Provide employment information

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

### Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.

## Definitions

### Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include financial companies such as: Mizrahi Tefahot Bank, Israel and its branches and subsidiaries.

### Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Non-affiliates we can share with include: Item and/or Data Processors, Credit Bureaus, Appraisers, Title Companies and Check suppliers.

### Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Mizrahi Tefahot Bank Ltd., Los Angeles Branch doesn't jointly market.

## Other important information

California Residents: Your state law requires financial institutions to obtain your consent prior to sharing information about you with non-affiliated third parties. Except as permitted by law, we will not share information we collect about you with non-affiliated third parties while you are a resident of California.
